Business and Anticipated Business Plan

6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

Resolve Networks is building a gaming platform where individuals and groups make a real-world social impact and earn money for causes they care about. In short, completed game missions create money going to charity, which is a purpose that people can get excited about.

Most people have the desire to help those they have an affinity for, driven in large part by the science of our serotonin and oxytocin reward systems. Today in late 2020 more than ever before, individuals, families, and teams are actively seeking opportunities to give in non-monetary ways. The mission of Resolve Networks is to prove that “good” is more than charity. The venture intends to make money when companies sponsor in-game activities that align with their brand’s purpose motives.

83% of B2B & B2C audiences feel companies should only earn a profit if they deliver a positive impact, yet only 37% believe companies actually do. What’s more, if a brand genuinely operates with a clear and strong purpose, those audiences are 6 times more likely to support the company in the event the brand has a “misstep” or receives public criticism. Demonstrating purpose strengthens brand trust and affinity while increasing brand preference, advocacy, and protection.

Players create social impact to earn coins. The value of those coins is equal to the value of the outcome players create, e.g. 50,000 items of trash collected. A brand in this example can examine the photos and testimonials of hundreds of players who contributed, and then choose to sponsor that completed outcome for \$5,000 using tax deductible funds. What’s more, data describing the outcomes created by the mission beneficiary using the donation funds offer future real-world value from the marketing investment. A Win-Win.

The Resolve Networks platform connected brands, consumers, and charities in a virtuous circle. Each member of this 3-sided marketplace achieves a win based on the real social impact that is both measured and proven. The company conducted paper prototyping before developing its prototype platform and proof of concept game titles.

Today, that game title Comeback League and a 2nd game title 0Trace (pronounced zero-trace) are available on the Apple App Store and the Google Play store. Anyone can download and play these proof of concept game titles to better understand the player experience before they consider investing, or joining our developer community. Capital raised in 2020 is planned to support the development and release of additional game titles that focus on different affinity audiences/causes.

Resolve Networks currently has 3 employees.

Risk Factors

1. If the Company is unable to raise additional capital on acceptable terms, it may be unable to maintain sufficient growth or commercialize its products. The Company may require substantial future capital in order to continue to conduct the research, product development, and marketing required to scale the business. There can be no assurance that additional funding will be available on acceptable terms. Failure to satisfy our capital requirements may adversely affect the Company's business, financial condition, and results of operations because the Company would be left without the capital required to complete product development or establish sales and marketing capabilities.
2. The United States and other countries have experienced and may experience in the future, major health epidemics related to viruses, other pathogens, and other unforeseen or catastrophic events, including natural disasters, extreme weather events, power loss, acts of war, and terrorist attacks. For example, there was an outbreak of COVID-19, a novel virus, which has spread to the United States and other countries and declared a global pandemic. The global spread of COVID-19 has created significant volatility and uncertainty in financial markets. Although COVID-19 is currently not material to our results of operations, there is significant uncertainty relating to the potential impact of COVID-19 on our business. The extent to which COVID-19 impacts our current capital raise and our ability to obtain future financing, as well as our results of operations and financial condition, generally, will depend on future developments which are highly uncertain and cannot be predicted, including new information which may emerge concerning the severity of COVID-19 and the actions taken by governments and private businesses to contain COVID-19 or treat its impact, among others. If the disruptions posed by COVID-19 continue for an extensive period of time, our business, results of operations, and financial condition may be materially adversely affected.
3. Start-up investing is risky. Investing in early-stage companies is very risky, highly speculative, and should not be made by anyone who cannot afford to lose their entire investment. Unlike an investment in a mature business where there is a track record of revenue and income, the success of a startup or early-stage venture often relies on the development of a new product or service that may or may not find a market. 4. Your shares are not easily transferable. You should not plan on being able to readily transfer and/or resell your security. 5. This Round of funding might not be sufficient for the company to achieve its short-term goals hence it plans to conduct an Angel Round subsequent to the closure of this Round. Issuance of additional shares of stock will dilute your ownership of RESOLVE NETWORKS, INC.
6. The failure to attract and retain key employees could hurt our business, and our management does not have extensive experience in the operation of businesses such as ours. Our success also depends upon our ability to attract and retain numerous highly qualified employees. Our failure to attract and retain skilled management and employees may prevent or delay us from pursuing certain opportunities. If we fail to successfully fill many management roles, fail to fully integrate new members of our management team, lose the services of key personnel, or fail to attract additional qualified personnel, it will be significantly more difficult for us to achieve our growth strategies and success.
7. We are highly dependent on the Services of our founder. Our future business and results of operations depend in significant part upon the continued contributions of our CEO and founder. If we lose those services or if he fails to perform in his current position, or if we are not able to attract and retain skilled employees in addition to our CEO and the current team, this could adversely affect the development of our business plan and harm our business. In addition, the loss of any other member of the board of directors or executive officers could harm the Company’s business, financial condition, cash flow and results of operations.
8. Our management may not be able to control costs in an effective or timely manner. The Company’s management anticipates it can use reasonable efforts to assess, predict and control costs and expenses. However, implementing our business plan may require more employees, capital equipment, supplies or other expenditure items than management has predicted. Likewise, the cost of compensating employees and consultants or other operating costs may be higher than management’s estimates, which could lead to sustained losses.
9. Valuation and capitalization. Unlike listed companies that are valued publicly through market-driven stock prices, the valuation of private companies, especially startups, is difficult to assess and you may risk overpaying for your investment. In addition, there may be additional classes of equity with rights that are superior to the class of equity being sold.

The securities being offered have not been registered under the Securities Act of 1933 (the "Securities Act"), in reliance on exemptive provisions of the Securities Act. Similar reliance has been placed on apparently available exemptions from securities registration or qualification requirements under applicable state securities laws. No assurance can be given that any offering currently qualifies or will continue to qualify under one or more of such exemptive provisions due to, among other things, the adequacy of disclosure and the manner of distribution, the existence of similar offerings

in the past or in the future, or a change of any securities law or regulation that has retroactive effect. If, and to the extent that, claims or suits for rescission are brought and successfully concluded for failure to register any offering or other offerings or for acts or omissions constituting offenses under the Securities Act, the Securities Exchange Act of 1934, or applicable state securities laws, the Company could be materially adversely affected, jeopardizing the Company's ability to operate successfully. Furthermore, the human and capital resources of the Company could be adversely affected by the need to defend actions under these laws, even if the Company is ultimately successful in its defense.

12. *The Company has the right to extend the Offering Deadline, conduct multiple closings, or end the Offering early.*

The Company may extend the Offering Deadline beyond what is currently stated herein. This means that your investment may continue to be held in escrow while the Company attempts to raise the Minimum Amount even after the Offering Deadline stated herein is reached. While you have the right to cancel your investment up to 48 hours before an Offering Deadline, if you choose to not cancel your investment, your investment will not be accruing interest during this time and will simply be held until such time as the new Offering Deadline is reached without the Company receiving the Minimum Amount, at which time it will be returned to you without interest or deduction, or the Company receives the Minimum Amount, at which time it will be released to the Company to be used as set forth herein. Upon or shortly after release of such funds to the Company, the Securities will be issued and distributed to you. If the Company reaches the target offering amount prior to the Offering Deadline, they may conduct the first of multiple closings of the Offering prior to the Offering Deadline, provided that the Company gives notice to the investors of the closing at least five business days prior to the closing (absent a material change that would require an extension of the Offering and reconfirmation of the investment commitment). Thereafter, the Company may conduct additional closings until the Offering Deadline. The Company may also end the Offering early; if the Offering reaches its target offering amount after 21-calendar days but before the deadline, the Company can end the Offering with 5 business days' notice. This means your failure to participate in the Offering in a timely manner, may prevent you from being able to participate - it also means the Company may limit the amount of capital it can raise during the Offering by ending it early.

13. *The Company's management may have broad discretion in how the Company uses the net proceeds of the Offering.*

Despite that the Company has agreed to a specific use of the proceeds from the Offering, the Company's management will have considerable discretion over the allocation of proceeds from the Offering. You may not have the opportunity, as part of your investment decision, to assess whether the proceeds are being used appropriately.

14. *The Securities issued by the Company will not be freely tradable until one year from the initial purchase date. Although the Securities may be tradable under federal securities law, state securities regulations may apply, and each Investor should consult with his or her attorney.*

You should be aware of the long-term nature of this investment. There is not now and likely will not be a public market for the Securities. Because the Securities offered in this Offering have not been registered under the Securities Act or under the securities laws of any state or non-United States jurisdiction, the Securities have transfer restrictions and cannot be resold in the United States except pursuant to Rule 501 of Regulation CF. It is not currently contemplated that registration under the Securities Act or other securities laws will be affected. Regulation CF requires only the provision of an annual report on Form C and no additional information - there are numerous methods by which the Company can terminate annual report obligations, resulting in no information rights, contractual, statutory or otherwise, owed to Investors. This lack of information could put Investors at a disadvantage in general and with respect to other security holders.

16. *The shares of Securities acquired upon the Offering may be significantly diluted as a consequence of subsequent financings.*

Company equity securities will be subject to dilution. Company intends to issue additional equity to future employees and third-party financing sources in amounts that are uncertain at this time, and as a consequence, holders of Securities will be subject to dilution in an unpredictable amount. Such dilution may reduce the purchaser's economic interests in the Company.

17. The amount of additional financing needed by Company will depend upon several contingencies not foreseen at the time of this Offering. Each such round of financing (whether from the Company or other investors) is typically intended to provide the Company with enough capital to reach the next major corporate milestone. If the funds are not sufficient, Company may have to raise additional capital at a price unfavorable to the existing investors. The availability of capital is at least partially a function of capital market conditions that are beyond the control of the Company. There can be no assurance that the Company will be able to predict accurately the future capital requirements necessary for success or that additional funds will be available from any source. Failure to obtain such financing on favorable terms could dilute or otherwise severely impair the value of the investor's Company securities.

18. *There is no present public market for these Securities and we have arbitrarily set the price.*

The offering price was not established in a competitive market. We have arbitrarily set the price of the Securities with reference to the general status of the securities market and other relevant factors. The Offering price for the Securities should not be considered an indication of the actual value of the Securities and is not based on our net worth or prior earnings. We cannot assure you that the Securities could be resold by you at the Offering price or at any other price.

19. In addition to the risks listed above, businesses are often subject to risks not foreseen or fully appreciated by the management. It is not possible to foresee all risks that may affect us. Moreover, the Company cannot predict whether the Company will successfully effectuate the Company's current business plan. Each prospective Investor is encouraged to carefully analyze the risks and merits of an investment in the Securities and should take into consideration when making such analysis, among other, the Risk Factors discussed above.

The Offering

Resolve Networks, Inc. (“Company”) is offering securities under Regulation CF, through Netcapital Funding Portal Inc. (“Portal”). Portal is a FINRA/SEC registered funding portal and will receive cash compensation equal to 4.9% of the value of the securities sold through Regulation CF. Investments made under Regulation CF involve a high degree of risk and those investors who cannot afford to lose their entire investment should not invest.

The Company plans to raise between \$10,000 and \$1,070,000 through an offering under Regulation CF. Specifically, if we reach the target offering amount of \$10,000, we may conduct the first of multiple or rolling closings of the offering early if we provide notice about the new offering deadline at least five business days prior to such new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). Oversubscriptions will be allocated on a first come, first served basis. Changes to the offering, material or otherwise, occurring after a closing, will only impact investments which have yet to be closed.

In the event The Company fails to reach the offering target of \$10,000, any investments made under the offering will be cancelled and the investment funds will be returned to the investor.

8. What is the purpose of this offering?

To support 2021 growth, the company is raising a seed round with plans to:

- Initiate payroll and benefits for core team
- Build its channel enablement function for Marketing agencies (Brand, PR, Digital Marketing, etc.);
- Scale product development to support the 2021 plan and campaigns closed by the channel;
- Build a community of volunteers to work for a combination of coins and monetary compensation;
- Support guerilla and sweat equity marketing to attract players, non-profits, and brands;
- Expand the Comeback League and OTrace apps to one new country, with target countries including the UK, France, Canada, or Israel
- Add one to two new games to the platform in the United States with a target period of 2H2021.

10. How will the issuer complete the transaction and deliver securities to the investors?

In entering into an agreement on the Netcapital Funding Portal to purchase securities, both investors and Resolve Networks, Inc. must agree that a transfer agent, which keeps records of our outstanding Common Stock (the "Securities"), will issue digital Securities in the investor's name (a paper certificate will not be printed). Similar to other online investment accounts, the transfer agent will give investors access to a web site to see the number of Securities that they own in our company. These Securities will be issued to investors after the deadline date for investing has passed, as long as the targeted offering amount has been reached. The transfer agent will record the issuance when we have received the purchase proceeds from the escrow agent who is holding your investment commitment.

11. How can an investor cancel an investment commitment?

You may cancel an investment commitment for any reason until 48 hours prior to the deadline identified in the offering by logging in to your account with Netcapital, browsing to the Investments screen, and clicking to cancel your investment commitment. Netcapital will notify investors when the target offering amount has been met. If the issuer reaches the target offering amount prior to the deadline identified in the offering materials, it may close the offering early if it provides notice about the new offering deadline at least five business days prior to such new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). If an investor does not cancel an investment commitment before the 48-hour period prior to the offering deadline, the funds will be released to the issuer upon closing of the offering and the investor will receive securities in exchange for his or her investment. Financial Condition of the Issuer

Resolve Networks does not have predecessors. Its founder has self-funded all activity, bootstrapping product and brand creation, and the creation of partnership channels. Shipping a minimum viable product in the marketplace is intended to support the first financial milestone of the company, its initial seed fundraising using crowdfunding.

Capital from that fundraising is aimed at supporting 2021 operations, the execution of a strategy to improve the product and scale all elements of the business, including the number of game titles and the countries in which game titles are available. Showing progress and results is intended to support the 2nd financial milestone of the company, a seed round composed of Angel investors.

While the founder had liquidity to bootstrap the delivery of a minimum viable product, he does not have ample liquidity to fund the 2021 plan for rapid growth and would rely only on revenues to fund product development at a slower pace. Operationally, having first seed funds to compensate employees will accelerate the business compared to relying solely on volunteer or equity-only employee resources. As of December, 31 2019 the founder had contributed paid-in capital in the amount of \$15,498.

In the year ended on December 31, 2018, operating costs amounted to \$9,975 while for the year ended on December 31, 2019 operating costs amounted to \$5,573. Since we are in a pre-revenue stage these resulted in a net loss of \$9,975 in 2018 and \$5,573 in 2019.

Subsequent to December 31, 2019 the company has authorized 10 million shares of common stock and issued 7,430,000 new shares of common stock.

Video Transcription: Have you ever heard the expression “Kick ass, take names?” Well in my experience, everybody loves the first part, it’s the second part they suck at. But what if we use technology to help us really prove our social impact? I’m Mario Blandini and I’m the founder of Resolve Networks. My idea is based on my life experience, having served six years in the United States Marine Corps and over two decades in Silicon Valley aiming to explain data to others as well as volunteering for a lot of nonprofits who I found are not using the latest and greatest technology to prove their social impact. So you’re probably thinking, “Resolve Networks is a nonprofit.” Actually, it’s a for-profit gaming platform where players do real-world good, create a social impact, and earn money for causes they care about. I was born and raised in California and spent most of my life working in Silicon Valley but I chose to move here to Texas in order to make this company a reality.

Think of Resolve Networks as being a data company first and foremost, that records the gamification of good. How big is that TAM? Well, I say half a trillion dollars if you think about the current ecosystem of nonprofits, brand marketing, and social media. In Silicon Valley I worked as a technologist and a marketer and I found some data this year that was pretty surprising to me, but it helps to tell the story of why Resolve Networks was created.

A survey was conducted that asked 8,000 folks, "If a company does not make a social impact, does it deserve to make a profit?" 83% said no. A little unfair, but let's look at the second part of the survey where they asked the question "Of the brands that you currently buy from, how many of them actually do make a social impact?" And that number was 37%. So we got a 46 point gap in the perception on the importance of social impact and whether people actually do. And that's what this product is all about; brands sponsor outcomes created by the players. So you as a brand can look at the social impact that was created and if you like it, you buy it. You didn't have to pay upfront, you pay later. Even better? Because the money is going to charity, you can use pre-tax dollars to do that. So think about this new marketplace where beyond just philanthropy budgets, our marketing budgets serve as a force multiplier for the good that can be done to support the causes in our country.

Looking for our first investment, you can think of our seed funding strategy as having two parts. First, an equity crowdfunding campaign that engages users and allows them to be part owners of this company, and a second part to complete the seed driven by a group of angel investors who believe in this purpose.

For investors, my job is to deliver shareholder value and the plan to do that is to execute on delivering gold standard gaming metrics as well as digital marketing conversion metrics and following along with that social impact created by this venture in proving a purpose. We're all here together and I'm looking for partners in this to prove that good is more than charity. There's a couple different ways to participate. One, in the crowdfund. No need to be an accredited investor, you can play the game and be part owner in the venture that's making this reality possible. I'm also forming a team of angel investors to come together to complete that first seed round in two parts that'll help us deliver on our 2021 plan to grow our company out for years.

I got to admit, there's something in it for me. I have a strong desire to prove that my vision will become real and with that I need you, everybody, to come together because we're stronger together. So whether you're a player, investor, brand or non-profit, our journey starts by downloading the comeback league game from your app store, experience it for yourself, and take part in this mission that we're on to prove that good is more than charity.
